Re-Opening Wesley Manor's Facilities to Visitors

Due to diminishing infection rates in Jefferson County, Wesley Manor is now allowed to resume visitation of our residents in the Health Care Center, the Hoskinson House Assisted Living, and the Aldersgate Personal Care facility. We are beginning this immediately, and hopefully for a long time into the future.

Family members and friends, who wish to visit, need to follow the following protocols:

- Visitors need to have been fully vaccinated, have evidence of a recent negative COVID test, or have not been recently exposed to COVID and have no symptoms.
- Visitation is limited to one visitor. Two people may visit if they are from the same household.
- No children under the age of 12 are permitted.

- Face Coverings must be worn at all times during the visit.
- Social distancing (6 feet) must be maintained during the visit (Sorry, no hugging).
- Hand sanitizers are to be used before and after the visit.
- All visits must be scheduled at least one day in advance.
- Each visit lasts for 30 minutes. (This allows us to schedule more visits each day).

If a resident or staff person tests positive for the virus, Wesley Manor is required to put visits “on hold” for 14 days after the positive test.

We appreciate this first step in introducing some normalcy to our residents’ lives, and look forward to the day when all of this COVID pandemic is behind us.
